- -Pond erosion project update: Email from contractor stating they have received the necessary permit for the project. They are waiting for a date from the Safety Harbor Water Department to coordinate a time both can be onsite.
- -Insurance policies update: For numerous years, the BTW HOA has been using McGriff Insurance Services, domiciled in North Carolina, to handle our insurance needs. The renewal policies for property and wind came in with an increase of over 47%. The BTW HOA board obtained a quote from Guided Insurance Solutions, out of Tampa, for the same coverage for considerably less. The BTW HOA has moved to Guided Insurance Solutions as our agency of record for our insurance needs.

Mike Arnold

 Marshall St./Phillipe Parkway property update: The deal is dead. The homeowner adjacent to the property notified BTW HOA that their offer to purchase it is no longer on the table. BTW owns the property.

NEW BUSINESS

-Initiate 2023 budget discussion:

BTW HOA has gotten letters from 2 vendors already with substantial increases for next year citing higher material, labor and energy related costs.
